A motion was made, seconded and passed to accept the Treasurers report. The Dept. Audit Committee reported that the Treasurers books had been audited and found to be in good order.

**Dept. Officer and Camp Commander Reports:** were emailed prior to the Encampment for review. A motion was made, seconded and passed to accept the reports and have them placed on file.

Highlights of the 2015 Nat'l Encampment were discussed. Chap. Jerry reported that members of the Allied Orders met with CinC to discuss differences between the Orders.

Dept. Sec. Aarli highlighted some of the notes of the CofA meeting held at Richmond. Dept. Treas. Johnson reported on the status of the 2016 Nat'l Encampment planning Committee. Next meeting Dec. 5, 2016 in Marengo. Discussed using credit cards for Nat'l Encampment order forms. A motion was made, seconded and past to have Dept. Treas. to set this up through our bank. DC Lyon strongly recommended that correspondence should be on SUVCW letterheads (samples handed out) to look more professional. It was announced that DC Lyon was appointed Nat'l Eagle Scout Coordinator.

**COMMUNICATIONS:** Dept. Sec. Aarli reviewed a few letters that were previously sent to the Dept. Officers and Camps.

**AWARDS:** DC Lyon announced that at the 2015 Nat'l Encampment, the Dept. of Illinois received the Marshall Hope Award for the outstanding Dept. Newsletter "Rail Splitter" and PDC Terry Dyer received the Meritorious Service Award.

**OLD BUSINESS:** Bro. Reineke reported that his resolution submitted last fall will be discussed at the Sons of Confederate Veterans at their meeting next April. The issues revolving around the luncheon at the Lincoln Tomb event was discussed and the feeling was that the Dept. of Illinois would be interested in hosting the luncheon and will possibly be discussed at the CofA meeting to be held in November at Gettysburg. The Encampment approved having Chap. Jerry bring up this question at the CofA meeting in Gettysburg. A committee of Chap. Jerry, Reineke and Dyer had been appointed to above luncheon question. No report on possible USPS Logan stamp. Stephenson Memorial project was discussed with \$4500 received from Nat'l. so far.

**NEW BUSINESS:** Bro. Reineke proposed that a Dept. Standing Committee on Fraternal Relations be formed to promote our Ladies groups (Allied Orders) and promote better relations between our groups. A motion was made, seconded and passed with Bro. Reineke to act as Chairman. A letter from Col. Hecker Camp #443 stating they had as a Camp passed a resolution to restore the rank of Past Camp Commander to their Bro. Greg Carter who transferred to their Camp from our John A. Logan Camp #26

where he had served as Camp Commander. Pursuant to Nat'l. constitution and by-laws the Hecker Camp had voted in favor to restore Bro. Carter to the rank of PCC with all its privileges. A motion was made, seconded and passed by the Dept. Encampment to restore Bro. Carter to the rank of PCC.

SVC Zeien mentioned that Illinois soldiers buried at Gettysburg had no flags placed at their markers during Remembrance Day activities. Bro. Reineke donated 12 US flags to the Dept. of Illinois for such occasions. Chap. Jerry and PDC Westlake will take the flags to Gettysburg in November to place them at the Illinois Soldiers graves during this year's Remembrance Day. Dept. Sec Aarli brought up a suggestion to prepare a proposal of a by-law change to submit to Nat'l to change their by-laws in regards to PCC/PDC losing their titles when they transfer. After much discussion, the idea was withdrawn.

A motion was made, seconded and passed to purchase a casting made by PDC Stefany as a gift from Illinois to CinC Mortorff.

**BILLS:** The following bills were presented and ordered paid: Steve Aarli, Dept. Sec. supplies: \$102.14; Paul Zeien \$13.28 Rail Splitter; Terry Dyer Petersburg expenses \$52.76, Stuart Stefany supplies \$14.81. Total: \$182.99. Motion made, seconded and passed to pay the bills.

**Annual Encampment:** A motion was made, seconded and passed to hold the 2016 Annual Dept. Encampment in May 2016 in Sycamore and hosted by Camp #49. Dated to be determined.
